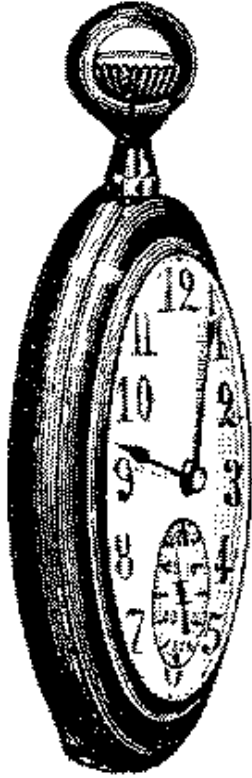

## Watch Repair Tips

I recently got a Knickerbocker watch in for repair. For those not familiar with this brand, its one name used by the New England Watch Company, and like their other products is a watch with a duplex escapement. After cleaning and oiling, I could not get good motion on the balance wheel. Upon closer examination I found a lot of wear on the slot in the balance staff where the escapement locks and unlocks. I lifted the escape wheel on it's arbor just enough to present a new wear surface on the balance staff

for the escape wheel, and the watch ran with good motion. Since replacement staffs are difficult to find for these watches, this trick can sometimes be used to bring an unusual watch back to life.☺

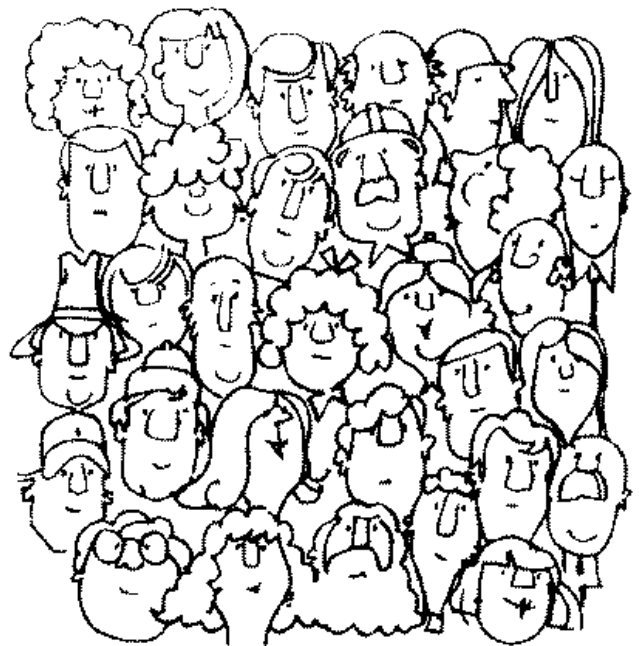

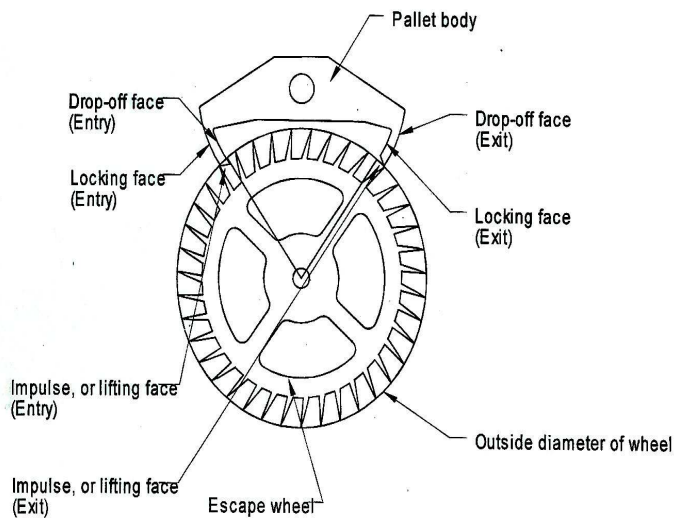
